

Early Intervention

Early Intervention is a statewide program, available locally, that provides quality support and services to enhance the capacity of families to meet the developmental needs of children from birth to age five, who have delays or disabilities. Early Intervention can help young children acquire the skills they need to grow into happy and healthy members of the community by building upon the natural learning occurring in the first few years of life. The CONNECT Helpline at 1-800-692-7288 will help answer questions about child development and specific disabilities. The Helpline can also refer a family to the appropriate local agency.

Intellectual Disability Services

Intellectual Disability Services through Supports Coordination are provided to people with an Intellectual Disability (ID) who have been deemed eligible for services by Bucks County's Department of Mental Health/Developmental Programs. Supports Coordinators (SCs) locate, coordinate, and monitor services for individuals and their families. SCs help find available programs including home care services, respite care, vocational and residential care, and other specialized services and supports.

Crisis and Emergency Services

Crisis and emergency services are available 24 hours a day for all Bucks County residents regardless of insurance coverage or financial resources. Services are provided in the Emergency Rooms of Doylestown Hospital and Lower Bucks Hospital. The Acute Care Center located on the grounds of Lower Bucks Hospital also offers services Monday through Friday from 8:00 am to 11:00 pm. At all locations, services can be provided in person or by telephone and include crisis assessment and referral. If necessary, facilitation of voluntary and involuntary hospitalization will be provided as well. Telepsychiatry, the use of real-time video conferencing, also is available at the Acute Care Center and will facilitate an interaction between a Child Psychiatrist and a child or adolescent in need of immediate psychiatric assessment.

Information and Referral Services

Information and Referral Services will assist children and their families with accessing services at Lenape Valley Foundation as well as in the community. Services are available by telephone and in person. Should you have a question or need an appointment, contact the Information and Referral Department.

Outpatient Services

A range of outpatient services are available for children and their families. The philosophy of Lenape Valley Foundation is to include the child's support system in treatment and service planning. Services include individual, family and group therapy, and psychiatry. Our therapists specialize in a variety of treatment modalities to fit the needs of children including play therapy, sand tray, and traditional talk therapies.

Blended Case Management (BCM)

Blended Case Managers coordinate and connect children and their families to behavioral health, educational and medical services, community resources, and insurance benefits they may need to maximize their quality of life and reach their goals. Blended Case Management Services are provided within the school, home, and community.

Behavioral Health Rehabilitation Services (BHRS)

Lenape Valley Foundation's Behavioral Health Rehabilitation Services (BHRS) offers intensive behavioral health treatment for children aged 1 to 21 and their families. Most services are provided in community and home settings. The treatment is collaborative, intensive, and multi-disciplinary, often consisting of child, family, Mobile Therapist (MT), a Behavioral Specialist Consultant (BSC), Therapeutic Support Staff (TSS), Licensed Psychologist, Children's Blended Case Manager, and additional systems providers. It is our mission to work collaboratively with the child and his/her family to offer the most competent, empathic treatment to empower and strengthen the child, family, and community connection.

Student Assistance Program (SAP)

The Student Assistance Program provides assessment and referral services to adolescents in the secondary education setting. Lenape Valley Foundation's SAP contract includes Central Bucks, Council Rock, Centennial, and New Hope-Solebury School Districts. Once the SAP team at a school refers the child to Lenape Valley Foundation's SAP, a liaison will go into the school to provide an assessment and assist the family in obtaining the needed mental health services that are recommended.
